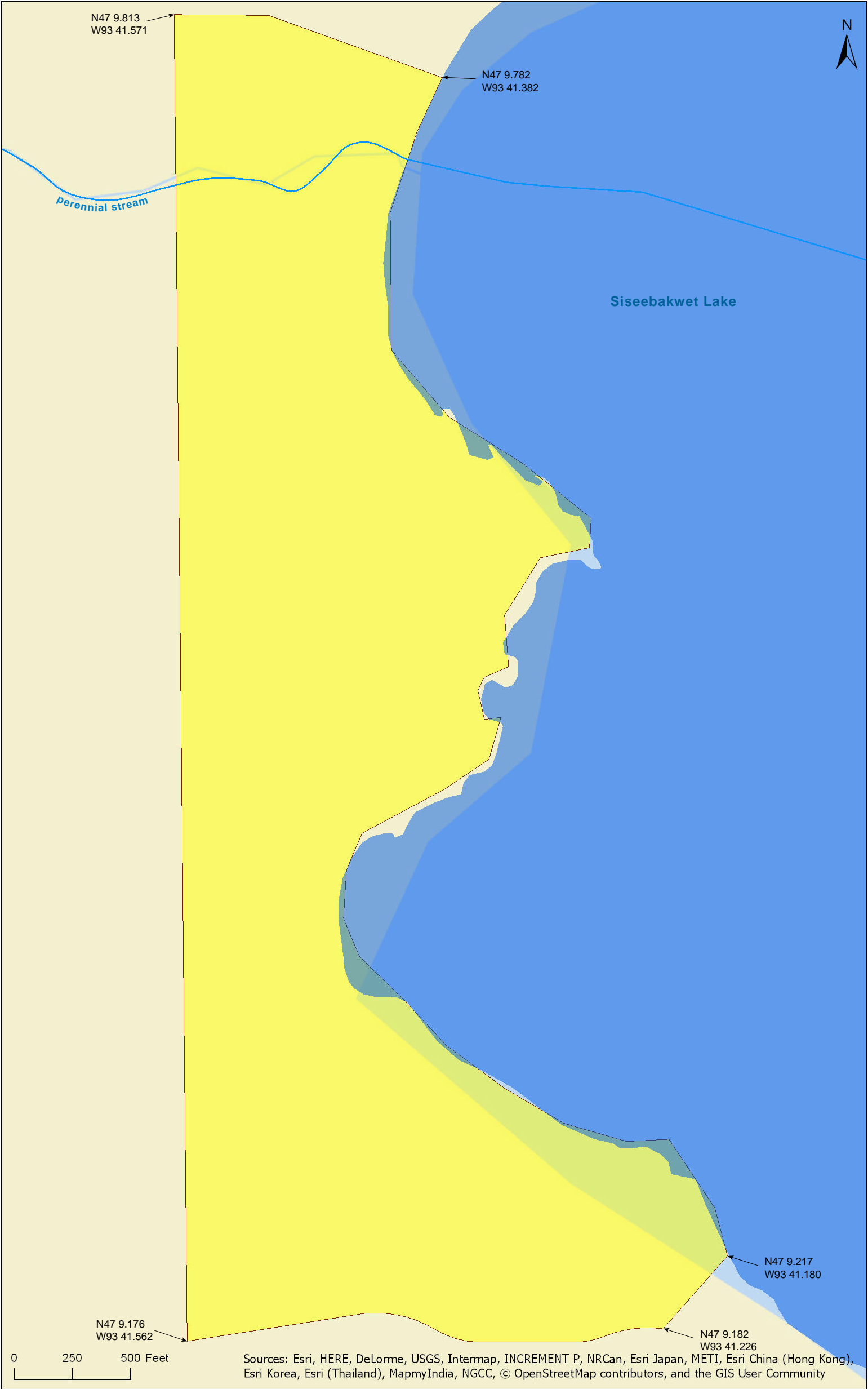

Directions and Notes from Minnesota DNR

Directions: From Grand Rapids 2 miles NW on US Hwy 2, then 3.5 miles W on Co Rd 63, then 3.5 miles SW on Co Rd 17, then 1.5 miles S on Co Rd 459, then 0.25 mile W on Co Rd 458 (N Sugar Lake Rd). Park in water access on S. Site is 1.25 miles SW in Siseebakwet Lake.
