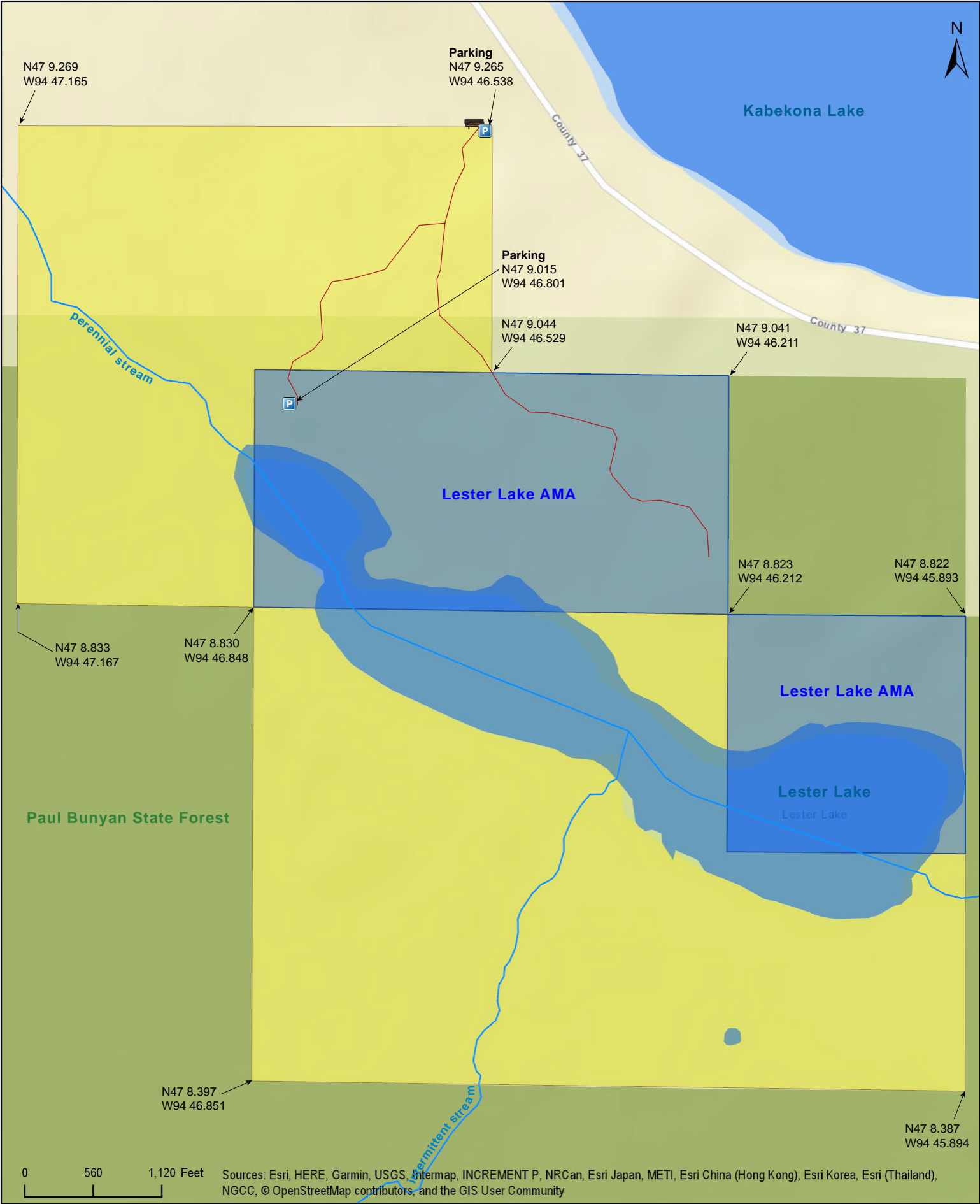

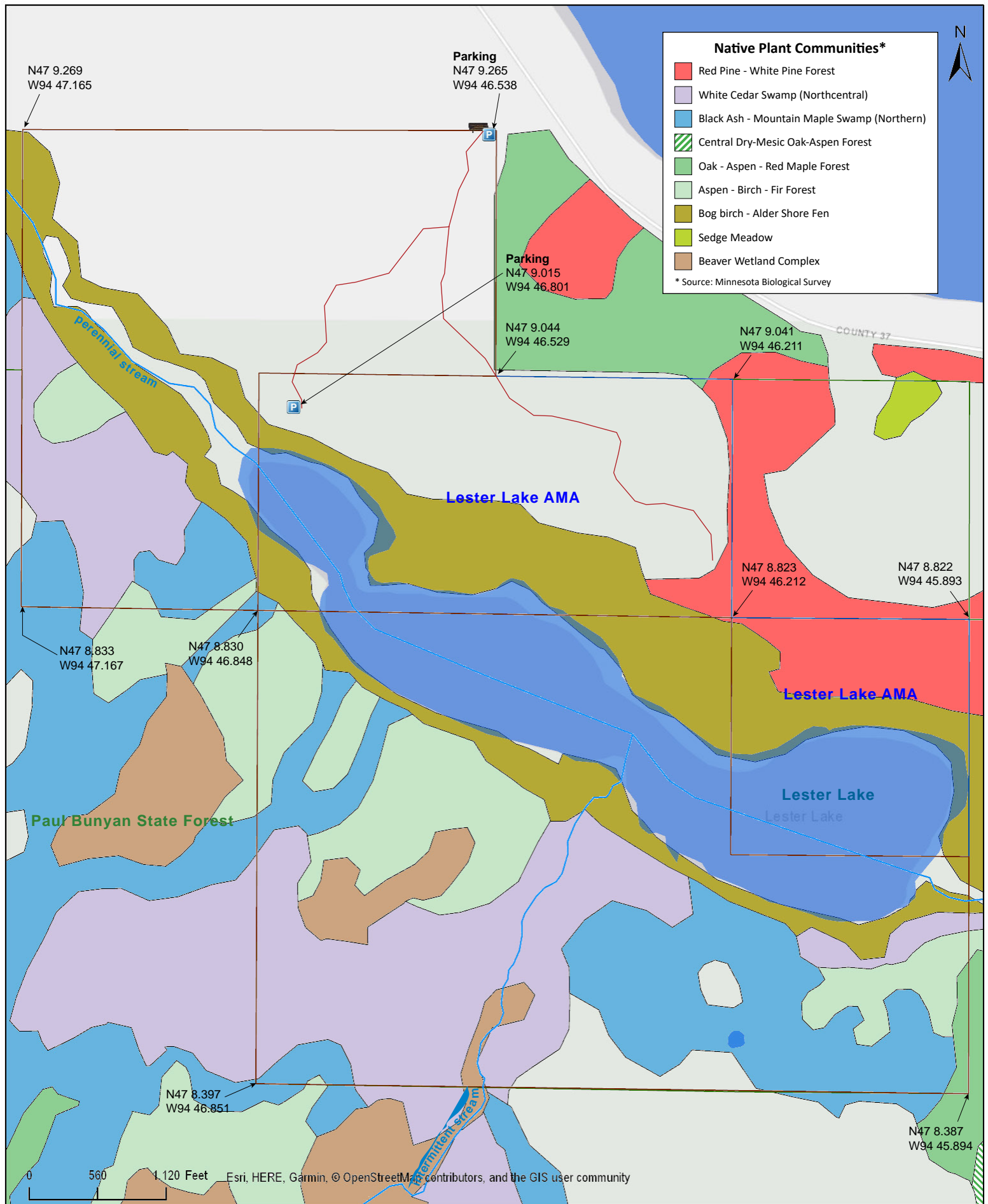

**Directions:** From Laporte 2 miles W on MN Hwy 200, then 3.5 miles S on MN Hwy 64. Then 1.5 miles SE on Co Hwy 37 (S Kabekona Lake Dr), then 375 feet W to parking lot.

**Lat/Lon:** 47.154414, -94.775633

### **Lester Lake**

**Directions:** From Laporte 2 miles W on MN Hwy 200, then 3.5 miles S on MN Hwy 64. Then 1.5 miles SE on Co Hwy 37 (S Kabekona Lake Dr), then 0.5 mile W then S on road to water access. Park in lot at dead end.

**Lat/Lon:** 47.150258, -94.780012
