




The Northern Tallgrass Prairie National Wildlife Refuge is a mosaic of land scattered across western Minnesota and Iowa. The refuge owns eight units that are open to the public, and manages 41 additional privately-owned easements which are not open to the public.

Hunting, wildlife viewing, interpretation, environmental education and photography are generally allowed on all Northern Tallgrass Prairie National Wildlife Refuge lands without a permit, unless otherwise posted.
