There is a field access on the east side of MN Hwy 104 at the west boundary of the preserve. Park on the field access. N45 25.704, W95 15.302

Parking (?), Field Road

There is a gated old field road on the east side of MN Hwy 104 at the west boundary of the preserve. Do not block the road. N45 25.629, W95 15.304

Parking (?), Old Driveway

There is a driveway on the east side of MN Hwy 104 near the southwest corner of the preserve. N45 25.224, W95 15.309
