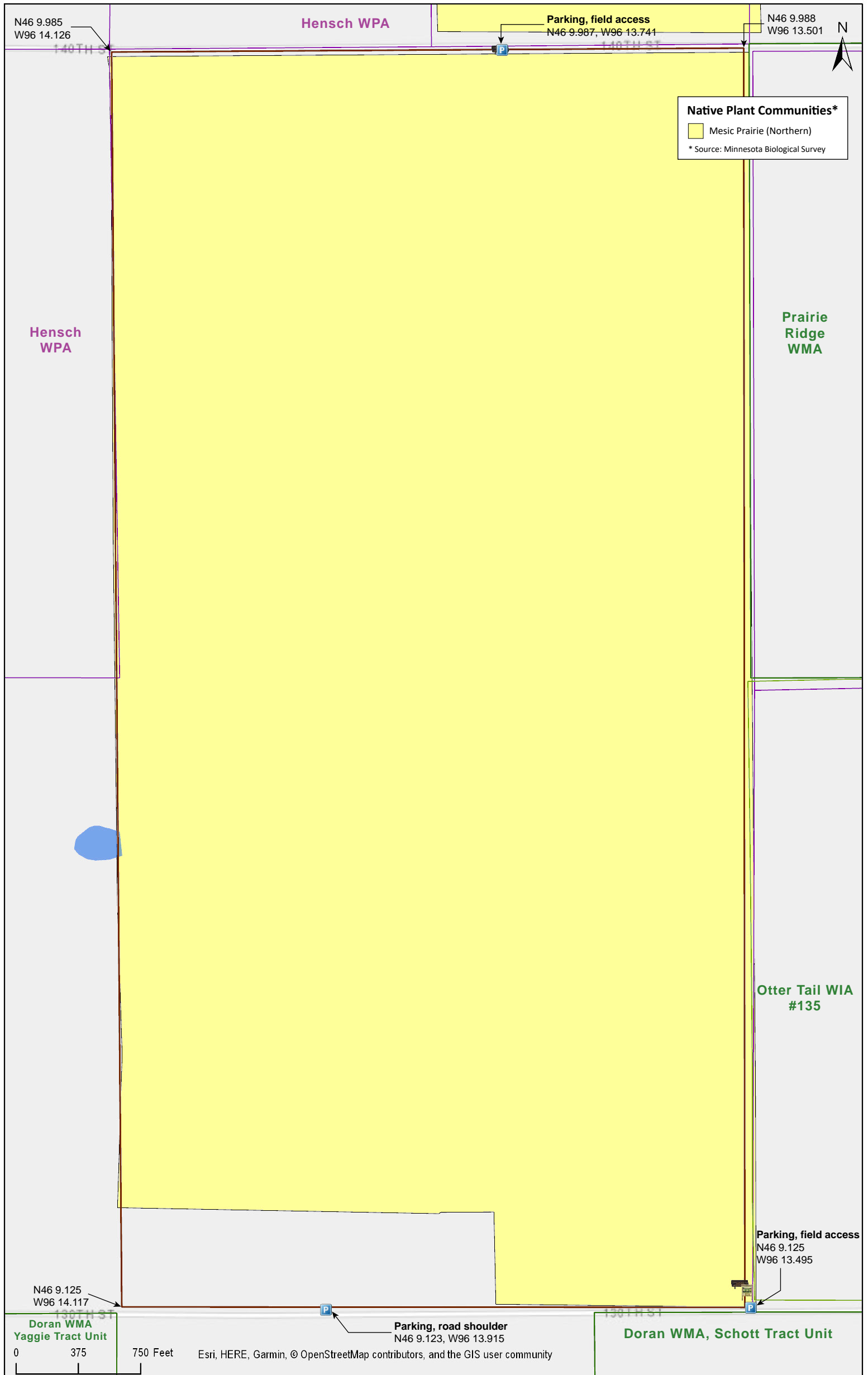

**Directions:** From Fergus Falls 7 miles S of I-94 on Co Hwy 1, then 7 miles W on Co Rd 112 (become 140th St), then 1 mile S on 135th Ave, then 1 mile W on 130th St. Park in pull-off on N.

**Lat/Lon:** 46.152053, -96.231912

This site has no maintained trails or other recreational facilities. Doran and Prairie Ridge WMAs are adjacent to this site.

### **Prairie Grassland Complex**

Otter Tail Prairie is part of a 3,200-acre block of land protected by the Minnesota Department of Natural Resources, U.S. Fish and Wildlife Service, and a private hunting and fishing club. Otter Tail Prairie SNA is bordered on the south by the Doran Wildlife Management Area; on the east by the Prairie Ridge Wildlife Management Area; on the north and west by the Hensch WPA; and by land owned and managed by the Fergus Falls Fish and Game Club, Inc., now Otter Tail Walk in Access site #351.

### **Wet Prairie**

Barely perceptible changes in elevation create areas that have standing water year round. Waterproof footwear is recommended.
