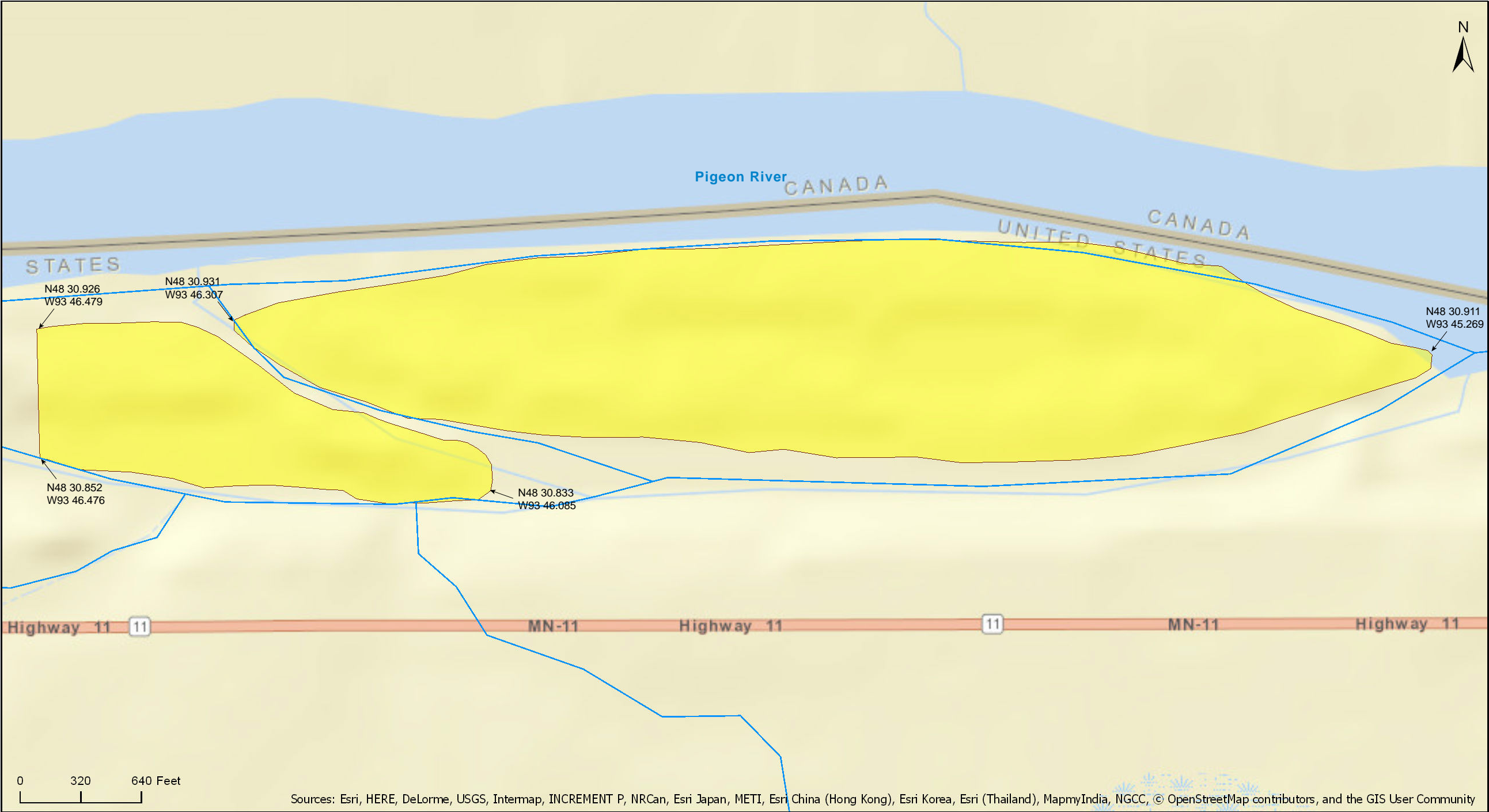

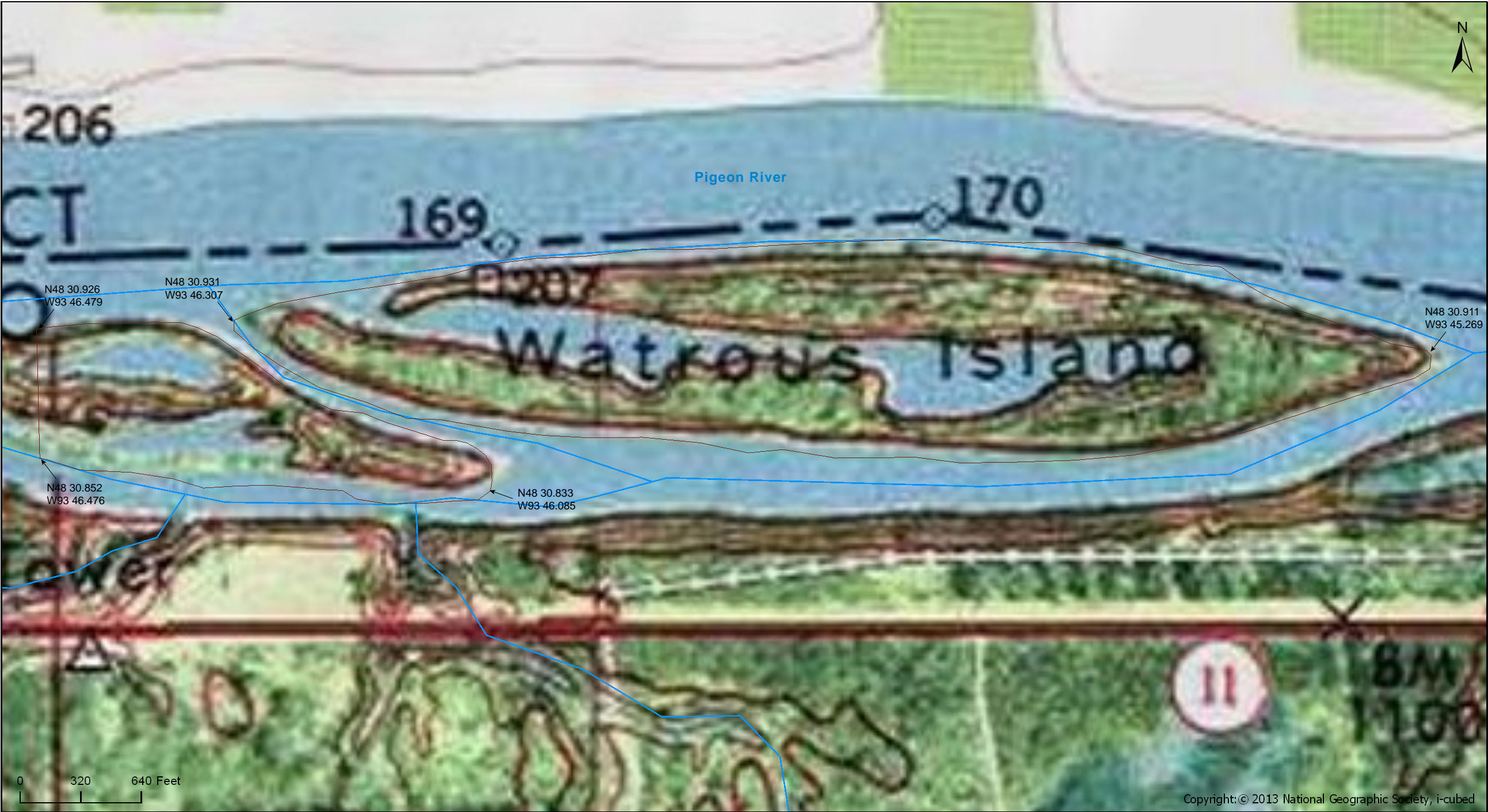

Directions: In Loman, from State Hwy 11, park in water access on N. Site is about 0.5 mile N on Black River, then 1 mile E on Rainy River. Accessible by boat.
